### 4 What personal information do we collect and how do we use it?

To undertake our purposes we may process the following personal information:

If you are **a visitor** to the Site:

- Name and job title.
- Contact information including email address.
- Demographic information such as postcode, preferences and interests.
- Navigation Data.
- Other information relevant to provision of Services.
- Third Parties Data provided by you.

Please note that if you provide us with third parties data, you should ensure that such parties have been informed in advance about the purposes and methods of the processing of their data indicated therein. In this case, you will act as autonomous data controller, assuming all legal obligations and responsibilities, and you undertake to ensure that this processing is based on a suitable legal basis. Therefore, you undertake to indemnify and hold harmless the Data Controller against any dispute, claim, request for compensation for damage caused by processing, etc. by third parties whose personal data have been processed through the sending, for example, of your application in violation of the applicable data protection regulations.

# If you are an prospective customer:

# What is our legal basis?

Where we use your personal information in connection with recruitment it will be in connection with us taking steps at your request to enter a contract we may have with you or it is in our legitimate interest to use personal information in such a way to ensure that we can make the best recruitment decisions for Toshiba Global Commerce Solutions. We will not process any data belonging to special categories except where we are able to do so under applicable legislation or with your explicit consent.

### 6 THIRD PARTY CONTRACTORS AND OTHER CONTROLLERS

As mentioned above, we may appoint sub-contractor data processors as required to deliver the Services, such as, without limitation, maintenance and support services, professional services, cloud services, who will process personal information on our behalf and at our direction. We conduct an appropriate level of due diligence and put in place necessary contractual documentation in relation to any sub-contractor to ensure that they process personal information appropriately and according to our legal and regulatory obligations.

Further, we may appoint external data controllers in common where necessary to deliver the Services (for example, but without limitation Toshiba Global Commerce Solutions entities). When doing so we will comply with our legal and regulatory obligations in relation to the personal information including but without limitation where necessary putting appropriate safeguards in place to ensure any personal information is processed according to our legal and regulatory obligations.

## 7 EXTRA-EEA TRANSFERS

If you are based within the EEA, please note that where necessary to deliver the Services we will transfer personal information to countries outside the EEA (including to Toshiba Global Commerce Solution's US entities) and other Toshiba Global Commerce Solutions entities via the Intra Group Data Sharing Agreement which utilises the standard contractual clauses set out by the European Commission as the extra-EEA transfer mechanism. When doing so we will comply with our legal and regulatory obligations in relation to the personal information including but without limitation having a lawful basis for transferring personal information and putting appropriate safeguards in place to ensure an adequate level of protection for the personal information.

### 8 How long do we keep your personal information for?

Generally, we will retain your personal information for the period of time strictly necessary for achieving the purposes for which the data were collected and in compliance with any applicable laws.

Regarding visitors to the Site, we will retain relevant personal information for at least one year from the date of our last interaction with you and in compliance with our obligations under the Data Protection Laws or for longer as we are required to do so according to our obligations.

Regarding personal information we have processed as part of providing the Services, we will retain relevant personal information for the period of time requested by the applicable civil and tax law and in compliance with our obligations under the Data Protection Laws (or for longer as we are required to do so according to our regulatory obligations). We may then destroy such files without further notice or liability. If you request your files and documents we may charge you for the costs of copying a duplicate.

If personal information is only useful for a short period e.g. for specific marketing campaigns we may delete it, after a period of time not exceeding one year from the date of our last interaction with you

Regarding personal information we have processed as part of the recruiting process, we will retain relevant personal information for the period of time strictly necessary for the management of the recruiting process and in compliance with any applicable laws- including Data protection Laws.

As per as personal information we may process in the context of Help Desk Service, we invite you to visit the privacy policy available on the Site.

### 9 CONFIDENTIALITY AND SECURITY OF YOUR PERSONAL INFORMATION
